President Pen...

Dear Friends,

Greetings from Delhi Medical Association!

With the New Government under Ms Rekha Gupta as Chief Minister & Dr Pankaj Singh as Health Minister, presence of our Past President, Dr Anil Goyal & our family member, Umang Bajaj as Legislators in New Assembly, Medical Profession has great hopes of solution to our long pending issues. With inputs from our Service Doctors, I have compiled a small note for your kind perusal. We are listing all issues faced by Medical Profession in our note & are seeking an appointment with Authorities to take up the matters in right earnest.

The Government of Delhi is deploying service doctors from Delhi Health Service (DHS) and Central Health Service (CHS). While the Department of Health & Family Welfare is the Cadre Controlling Authority for Officers of Delhi Health Service, the Ministry of health & FW, Govt. of India is the Cadre Controlling Authority for CHS Doctors. Both these Cadres have four functional subdivisions or sub-cadres viz. its GDMO's (the largest sub-group) and Specialists which includes Teaching, Non-teaching and Public Health sub-cadres. They are all governed by the DHS/CHS Rules and work on duty posts identified in the respective services.

The following issues related to service doctors of Delhi are important and deserve policy changes in the larger public interest:

- a) **Proper Cadre Management** and time bound promotion orders to be issued timely. Appointment of Ad-hoc & Contractual Doctors should be stopped immediately & Doctors should be appointed on Regular Posts by proper procedure. Government should be a Model Employer and there should not be even a semblance of Exploitation of Medical Professionals.
- b) **CDMO's head the districts** and are SAG Grade Officers who work under the Director of Health Services. but by a recent order of the previous government, they are being made to get their ACR's reported by the District Magistrates.
- c) The Conveyance allowance of doctors is not being disbursed timely despite court orders.
- d) SAG Officers barring a few, are not getting transport allowance to which they are entitled.
- e) Despite a declared transfer policy, transfer of service doctors are being done randomly.
- f) The retirement age of service doctors was enhanced to 65 years by PM Modi ji in 2016, but the senior doctors holding administrative positions are denied the same once they turn 62.
- g) Cadre review of DHS has not been done since its formation in 2009.
- h) Despite the policy of one man one post, some select officers, some very junior, are heading more than one hospital.

Respected Seniors and Dear Colleagues,

The landscape of private medical practice in India is undergoing significant change. Independent practitioners and small nursing homes, once the backbone of our healthcare system, are now struggling under increasing government regulations, financial burdens, and the dominance of corporate hospitals. At the same time, digitalization in healthcare presents both

opportunities and challenges, altering the way doctors manage their practices and interact with patients.

For decades, private practitioners have played a crucial role in providing accessible healthcare, especially in semi-urban and rural areas. However, complex regulatory requirements, including fire NOC, environmental clearances, and licensing hurdles, have made it increasingly difficult for small clinics to function. Rising operational costs, including rent, staff salaries, and compliance expenses, have further strained independent practice. Meanwhile, corporate hospitals, backed by strong marketing and the convenience of cashless insurance, are drawing patients away from private clinics, making solo practice economically unviable. Additionally, the growing threat of medical litigation has created a climate of fear, discouraging doctors from practicing independently.

While digitalization through initiatives like the Ayushman President-Elect, DMA (2025-26)



Bharat Digital Mission promises to modernize healthcare, its implementation poses concerns. Setting up electronic health records (EHRs) and telemedicine platforms requires significant investment, which small clinics may struggle to afford. There are also concerns about data security, privacy breaches, and the increasing reliance on virtual consultations, which can never fully replace the value of in-person doctor-patient interactions.

To address these issues, it is essential for policymakers to simplify licensing procedures, introduce a single-window clearance system for clinics, and offer financial incentives for digital adoption. Regulations must also be balanced to ensure corporate hospitals do not overshadow independent practitioners. By taking these steps, we can create a healthcare system where modernization supports, rather than replaces, the invaluable role of private medical practice.

Let's all of work unitedly and in synchronized manner in association and with government to address these challenges.

AMENDMENT 1

Article 15

ELECTION OF PRESIDENT ELECT AND TWO VICE PRESIDENTS

Election Commission

The State Executive Committee shall appoint Election Commission comprising of Seven members, one of which shall act as Chairman of the commission and Hony. Secretary as the convenor. Any body who is contesting shall not be the part of the Commission. The

Chairman, Election Commission shall on or before 10th January each year call the nomination through DMA News Bulletin from the valid members as on 31st December of Previous year.

A valid voter list with available phone nos. & e-mails should be provided to the contestants for better/electronic communication to voters.

Voting

The election for the above posts shall be held with the use of most modern technology aimed at increasing the participation of maximum members and ensuring the fairness of procedures. Therefore A valid voter list with available phone nos. & E-mails should be provided to the contestants for better/electronic communication to voters.

POLLING BOOTH VOTING BY SECRET BALLOT OR ELECTRONIC VOTING MACHINE

- a) For the post of President Elect
- b) Two Vice Presidents

Criteria for the Candidature:

- a) President elect and Vice Presidents
- i) Minimum 5 years of continuous membership of the association either direct or through a local branch or through both.
- ii) Must enroll himself as life member of IMA.
- ii-(a) Any member seeking election to the above mentioned elective posts of DMA should have been either a member of the State Executive for 3 years or should have held any post of DMA as Office bearers for at least one year.
- iii) A candidate who polls less than 5% of total votes polled shall not be eligible to contest for any of the above for next 3 years.

POLLING BOOTH VOTING BY SECRET BALLOT OR ELECTRONIC VOTING MACHINE

Criteria for the Candidature:

- a) President elect and Vice Presidents
- i) Minimum 5 years of continuous membership of the association either direct or through a local branch or through both.
- ii) Must enroll himself as life member of IMA.
- ii-(a) Any member seeking election to the above mentioned elective posts of DMA should have been either a member of the State Executive for 3 years or should have held any post of DMA as Office bearers for at least one year.
- ii) A candidate who polls less than 5% of total votes polled shall not be eligible to contest for any of the above for next 3 years.

AMAENDMENT NO.2

Article 15 ELECTION PROCESS

I) The election shall be held by secret ballot (at the time of polling) issued to all members on the rolls of association on whose behalf H.F.C. has been deposited by 31st December along with a list of valid members on whose behalf HFC has been deposited. The valid list shall also be displayed on the notice board of DMA and same with sent to the branch Secretaries by 10th January of every year.

- ii) Ballot papers shall bear the seal of the association and signature of any two members of the Election Commission for this purpose. No envelope shall be necessary for the Ballot Paper. Ballot papers will be delivered to the Chairman, Election Commission at least 48 hours before the Polling date.
- iii) The ballot paper shall be issued by the polling Officer to the valid members against the signature after establishing the identity through one of the means- identity card issued by DMA or IMA, driving licence, ration card, if he or she is the head of the family identity card issued by Government agencies, pass port or verification of signatures from the membership allocation Form. In no case any member shall be issued ballot paper in absence of aforementioned criteria unless until his/her identity is verified by all concerned in writing on the ballot paper.

Each member shall be issued separate ballot paper each year for post of President elect and two Vice- Presidents.

- iv) The ballot box shall be sealed in presence of President/Vice President, one of the Secretaries, Presiding Officer/Election Commission and Candidates or their observer for the election.
- v) The Ballot Box shall be kept in the custody of the Presiding Officer during the Polling time and shall be kept in the office under the key which shall remain with Chairman, Election Commission.
- vi) After total polling is over, the counting shall take place immediately. The Chairman, Election commission and his team shall hand over the sealed ballot box to the team of Scrutinizers (3-5) appointed by the Election Commission.

The Chairman shall open the ballot box before the Scrutinizers and the candidates or their Observer nominated by them, and hand over the ballots to the Scrutinizers. The Ballot papers would be counted and if any discrepancy between ballots issued and recovered from the box is found, it shall be recorded and signed by the Chairman and the Scrutinizers.

Article 15

ELECTION PROCESS

The necessary changes should be done in code of conduct in line with Evoting process.

The election commissioners along with returning officer shall select and approve the E voting agency after due diligence after taking presentation on technological, financial parameters and past record of said agency.

- 1. The election shall be held by E Voting after having given a clear time of 10 Days for canvassing Every ONE year.
- 2. The preparation for evoting must start immediately after the date of withdrawal.
- 3. All the candidates or their representatives must be explained the complete procedure for e Voting and counting at least two days before the Voting starts.
- 4. No loopholes be left for any kind of manipulation in the process of e Voting and counting. All necessary safeguards, which technology allows may be adopted to give fair and correct results like OTP, single IP address etc.
- 5. The E voting agency will revalidate results through independent verifying agency.
- 6. The e Voting can start immediately after canvassing period is over.
- 7. The e Voting will be allowed for 48 hrs starting at 10 am and ending at 10 am as per schedule of election.
- 8. The counting of votes shall start at 4 PM on the Day when e Voting ends.
- 9. The counting shall be done by the five Scrutinisers appointed by the Election commission.
- 10. Each candidate shall be entitled to send one Observer for the counting.
- 11. The final results shall be presented to the President who shall declare the same in executive meeting a day later.

vii) The Scrutinizers will count the votes before the candidates or their observers nominated by them, criteria for invalidating a vote would be mentioned on the ballot paper and the same shall act as guidelines for the Scrutinizers.

The ballot papers shall be sorted out separately for the President elect, Vice Presidents counted accordingly. viii) For each category the scrutinizers shall record the votes

polled in the names printed on the ballot papers.

ix) These results shall be signed by all the scrutinizers and submitted to the President, who shall place these results before the State Executive Committee within 2 days of receiving it. Among the Vice Presidents, candidate polling maximum votes shall be the Senior Vice President. For any post candidate/s securing votes in order of merit shall be decided depending upon the number of seats vacant.
