CLINICAL ESTABLISHMENT ACT - A RECIPE FOR DISASTER

- ❖ Medical Profession is already governed by so many acts and regulatory bodies which monitor single Doctor Clinic to tertiary care Medical Establishment.
- ❖ The proposed act has taken away the power of State Government on an important subject like health which has always been a State subject, damaging the federal structure of Indian constitution.
- ❖ In Delhi State, Nursing Home Registration Act 1953 is already in place to govern medical establishments of the city.
- ❖ The proposed clinical establishment (registration and regulations) act will bring Inspector Raj and License Raj in Delhi which is becoming a centre of medical excellence for the whole World.
- ❖ Multi member inspection team comprising of non medical persons has been given the authority to inspect and penalize medical establishment and medical professions.
- ❖ Very harsh and penalties have been proposed to be imposed by authorities with little knowledge of medical illnesses and serious medical emergencies. In section-40, penalties have been proposed even without inquiry and a chance for the Doctors to explain. Quantum of penalties (ranging from Rs. Ten thousand to Rs. Five lacs) imposed in the act are too high in the backdrop of Socio-Economic canvas of our country.
- ❖ Emergency patients stabilization is a very serious clause in the proposed legislation in which, it has been made mandatory for all the above mentioned clinical establishments, even a single doctor clinic to have all the facilities for stabilizing patients of emergency medical conditions before being transferred to higher centers. A single doctor clinic and a tertiary care hospital have been equated with equal penalty to be judged again by people with non medical back ground.
- ❖ Allopathic medicine system which is giving medical care to more than 80% population is being represented by two or three members with allopathic medicine background in a National Council of 19 members and State Council of 21 members.
- ❖ In the act there is a total exclusion of judicial adjudicatory process. Appeal against orders of an administrative authority lies before another administrative authority which has been made to act as investigator, prosecutor as well as adjudicator.
- ❖ This proposed Act will adversely affect more than one lac Doctors from Allopathy, Ayurveda, Homeopathy, Dental Doctors and other Doctors in Delhi alongwith more than 20 lacs Healthcare personnel associated with Medical Establishments in the city.
- ❖ The act is in total violation of independence of doctors to setup their practice with ethics as per the needs of the society in and around them.
- ❖ Cost of medical treatment will escalate because of this act at all levels, jeopardizing the public health.
- ❖ The said act will lead to closure of small clinics, nursing homes and other medical establishments

Keeping in line with that thought, we also enrol 5 students every year for the DNB course in nephrology and train them thoroughly in the specialty. Message on the National Kidney Month

Each one must do their role as a responsible member of the society for spreading awareness for kidney health. Emphasis must be on prevention by the medical fraternity, social influencers in a concerted and sustained manner for the message to sink in the memory of the common man, so that they take care of their kidney health and prevent future complications. The adage, "An ounce of prevention is better than a pound of cure," cannot be truer in kidney care. Awareness must be a continuous process even after National Kidney Month.

Dr. D.S. Rana, Padma Shri and B.C. Roy Awardee & Chairman, Sir Ganga Ram Trust Society, is among the pioneers in Nephrology, who has been in the forefront of refining the specialty in India. An achiever and philanthropist at heart, his passionate appeal on National Kidney Month calls for focus on screening, detection and treatment of children for prevention of kidney disease, the burden of which is taking a toll on lives and resources.

What is the significance of observing National Kidney Month every year?

The objective is aimed at focusing all our efforts on that particular aspect of kidney disease so that throughout the year, we try to improve on benchmarks for managing that issue. This year's theme is "Are Your Kidneys OK? : Detect Early, Protect Kidney Health," This is a very crucial and relevant topic- whether your kidneys okay? But one has to understand the underlying reason why this question has come-up in the first place? With governments, the medical fraternity and other stakeholders in the speciality of nephrology and kidney care are pushing for more awareness and building manpower and facilities to tackle the issue of chronic kidney disease. Less than 10 percent people are aware that they are having kidney disease, which means more than 90 percent of them do not even know that they have such a condition.

How is Sir Ganga Ram Hospital collaborating with the government to help minimise the spread of kidney disease?

The Union Health Ministry has collaborated with Sir Ganga Ram Hospital to launch in the next month or two, a Screening for Early Evaluation and Early Detection of kidney disease (SEEK) Project. This SEEK project, will be largest study to be conducted for identifying kidney disease in the general population and shall cover, both the rural and urban population. The purpose of SEEED study is to raise awareness and the importance of early detection and intervention in kidney disease. My message, therefore, on the National Kidney is that when you act and start early, you can prevent many people from becoming CKD patients, who may need dialysis and kidney transplantation. You can save lives and huge financial burden to the country.
